Summer Camp Rates will include the following **discount** for Adult counselors: Jr. and Sr. High Camp – 1 free counselor for every 10 campers: Elementary Camp - 1 free counselor for every 5 campers.

Guarantee and Finances The costs of summer camps and retreats are based on a minimum of 40 paying people, including counselors, musicians, speakers etc. If you do not have 40 that is fine but, you will be required to pay a minimum charge. Example = \$2,800.00 (40 x \$70.00) for Retreats Example = \$6,000.00 (40 x \$150.00) for Summer Camps.

We, the guest group named above, wish to confirm our reservation for _____ number of guests. To reserve our requested dates, a non-refundable deposit of \$500 must accompany this contract. The deposit is applicable to the total of all fees.

We also agree to make final payment no later than the first day of our arrival unless previous arrangements have been made.

Cancellation Policy:

We understand that we may cancel this agreement at any time up to 90 calendar days prior to the beginning date of our retreat or camp. In doing so, we agree to forfeit our deposit. If we cancel this agreement at any time within the 90 day calendar period prior to the beginning date of our scheduled event, regardless of the contract signing date, we understand that we will be responsible for 75% of the guaranteed minimum fee (see example above). However, if New Life Camp can arrange a full or partial replacement group, then we may be eligible for a cancellation discount. ***Please Note: This is a legal business contract and binds the signer and his or her group to the terms stated herein. Please make a copy for your records and send the original copy to New Life Camp.***
